**2025-2026 MIDDLE AND UPPER SCHOOL FIELD TRIP COSTS**

Beginning in Grade 6, students have the opportunity to travel for various overnight field trips. We understand the financial burden these trips can be for families having to pay for multiple trips all at one time. In order to assist families in paying for these opportunities, we have elected to provide the option to roll the cost of these trips into the total tuition amount. This gives the option for families to pay over a twelve month period for the three Middle School trips and over twelve month period (the year of the trip) or twenty-four month period (the year before and the year of the trip) for the one Upper School trip. Additionally, there may be opportunities for fundraisers to help families with the cost of these trips.

**Automatic Withdrawal:**

Automatic withdrawal funds are drafted from your account on the 1st of the month beginning July 1. If the 1<sup>st</sup> is on a weekend or holiday, the withdrawal is made the following business day.

**Previous CCS paying families, please note: The business office will NOT automatically continue to withdraw funds from your account until the 2025-2026 tuition agreement is signed and returned for the new school year.**

**Non-Discrimination Policy: Every individual is unique, created as an image-bearer by Almighty God. **CCS LATE PAYMENT & REFUND POLICY**

**PAYMENTS:** Payments are due the 1st day of each month. Only payments through automatic withdrawal (ACH) will be accepted for monthly payments. If payment is not received by the 10th of the month, a \$40 late fee will be assessed. If you have difficulty making a payment and cannot meet the conditions stated in the policy, contact the CCS office immediately. We will make every effort to work out an acceptable payment plan with you, but we expect you to take the initiative.

**TUITION REFUNDS:** **Payment for the month of July is NON-REFUNDABLE.** Withdrawal on or before August 1st: August tuition payments are refundable as well as any future prepaid amounts. Withdrawal after August 1st: Tuition after the first of any month is non-refundable; any future prepaid months will be refunded.

**TERMS AND CONDITIONS**

1. **Definitions:** As used in these Terms and Conditions, Student Enrollment Agreement is the "Agreement," the term "you" means the parent(s) and/or guardian(s) who sign the Agreement. The term "CCS" means Cornerstone Classical School. "Child" or "student" refers to the student(s) whose enrollment is intended.
2. **Student-Family Handbook:** The policies stipulated in the handbook, such as they are and as they may be revised during the term of this enrollment agreement, are incorporated into this Student Enrollment Agreement.
3. **Termination and Refund:** The Agreement may be terminated prior to May 1 (prior to the start of the next school year) with a full refund of all monies paid to CCS except for the enrollment fee. The enrollment fee is non-refundable.
4. **Hardship Accommodations:** After May 1, you may request a Hardship Accommodation in order to be considered for relief of some or all of your obligations under this Agreement. CCS may, in its sole discretion, agree to terminate the Agreement and/or to provide full or partial relief of obligations under this agreement, including, if applicable, a refund of payments made. If you would like to be considered for a Hardship Accommodation, you should contact the Cornerstone Headmaster.
5. **Days not in Session or Missed:** No credit or refunds will be given for vacation or professional in-service days or student absences or illnesses. No credit or refunds will be owed if CCS must close because of inclement weather or emergency.
6. **Student Medical Emergency:** You authorize CCS to obtain immediate medical care, including from a hospital or physician other than your child's physician, if, in CCS's judgment, a medical emergency occurs and there is insufficient time to first contact you or your child's physician.

7. Suspension and Dismissal: CCS reserves the right to suspend or dismiss your child in CCS’s sole discretion for unsatisfactory behavior, if CCS does not have adequate expertise or resources for your child’s educational, medical or other, for violations of CCS’s policies, or if, for any reason, CCS determines it to be in the best interests of CCS. In CCS’s sole discretion, suspension or dismissal may be with or without notice.
8. Internet Use: You hereby release CCS and its employees from all claims, charges and damages of any nature arising from use or misuse of the Internet.
9. General Release: You hereby release CCS and its employees from all claims, charges and damages of any nature arising from your child’s misuse or unauthorized use of any CCS equipment, materials or any CCS asset.
10. Responsibility for Child’s Actions/Indemnification: You agree that you are responsible for loss, damage or destruction by your child of any property of CCS and for any damages for which CCS becomes liable or chargeable because of your child’s actions. You agree to defend, indemnify and hold CCS harmless from and against all legal liability whatsoever and for costs, expenses, losses, or damages directly arising out of any negligent or intentional action or inaction by your child(ren) which causes any injury, loss or liability. In the event that CCS is adjudicated to have been partially or solely legally responsible for injury/damage/loss, your duty to indemnify CCS shall continue, but not extend beyond the percent of responsibility attributed to CCS.
11. Default: In the event that you fail to perform any obligation imposed by this Agreement, CCS may, in its sole discretion, deny class attendance and/or participation in school activities, withhold academic reports and transcripts, revoke enrollment, and/or expel your student(s). In the event that CCS is forced to incur legal costs, including, but not limited to, attorney fees, to enforce any obligation imposed in this Agreement, such costs and fees shall be borne by you.
12. Entire Agreement: Except for items specifically incorporated by reference herein, this Agreement is the sole and entire contract between you and CCS and you acknowledge that you have not been induced to enter this Agreement by reason of any promise, conversation, document, representation or warranty and that this Agreement contains the entire understanding of the parties with respect to the matters contained herein, and supersedes all other written and oral agreements between the parties with respect to the such matters.
13. Acceptance by CCS: You acknowledge and agree that the Agreement is not binding upon CCS unless and until it is signed by an authorized CCS administrator.\

By signing below, you agree to pay, as due, the tuition and fees identified above for your student(s) as a condition of enrollment to Cornerstone Classical School (“CCS”) for the 2025-2026 school year.
